



APPLICATION FOR MULTIPLE ANIMAL LICENSE OR COMMERCIAL DOG KENNEL

New Renewal

Multiple Animal License: In order for you to temporarily maintain a total of four (4) or five (5) dogs and cats within the City at one residence, a Multiple Animal License must be obtained (Cottage Grove City Code Title 5-4-4 Subsection D). In no circumstances, will more than a total of five (5) dogs and cats be maintained at one residence, be allowed.

Commercial Dog Kennel: No person shall maintain in the City a kennel where dogs are kept for sale without securing a Commercial Dog Kennel license from the City Clerk and appropriate zoning approvals from the City Council. Commercial dog kennels are allowed by conditional use permit only in AG1, AG2, or R1 Zoning Districts. They are not allowed on single-family residential property.
